4. GYM TERMS, RULES & CONDUCT

- Access requires truthful completion and signature, payment, and compliance with posted rules and staff instructions. Passes and memberships are personal and non-transferable unless Dreamz confirms otherwise in writing.
 - Management may refuse entry, suspend access, cancel a membership or require a person to leave immediately for unsafe, aggressive, disruptive or irresponsible conduct, intoxication, non-payment, fraud, refusal of instructions, nuisance or risk to persons or property.
 - Smoking, vaping, alcohol, illegal drugs and food are prohibited in training areas. Water or sports drinks must be in closed containers. Appropriate training clothing, a shirt, closed athletic shoes and a personal towel are required; use the towel on benches and equipment.
 - Use equipment safely and return it after use. Do not drop weights, misuse machines, block walkways or use damaged equipment. Report faults, injuries, incidents, unsafe conditions and damage immediately.
 - Dreamz is not responsible for lost, stolen or damaged personal property to the maximum extent permitted by law. Users remain responsible for their belongings.
- A person causing loss or damage agrees to reimburse the reasonable value of repair, replacement, cleaning, investigation and related costs.
 - No one may train or coach clients for payment, solicit clients, promote services or conduct personal training business on or around the premises without written management approval. Breach may result in removal, termination without refund to the extent permitted by law and a reasonable evidence-based claim for loss or damage.
 - Do not photograph, film, livestream or record staff, members, visitors or others without that person's prior permission and staff approval. Stop immediately when instructed.
 - Dreamz may reasonably update house rules, opening hours, safety instructions and access procedures for safety, hygiene, security, staffing, maintenance, legal compliance or operations. Current posted or communicated rules apply.
 - Except where mandatory law or a material failure by Dreamz requires otherwise, memberships, passes, registration fees, add-ons, sessions and correctly supplied products are final, non-refundable and non-transferable from purchase, including same-day requests. Non-use and personal circumstances create no refund, credit, pause or extension right.

5. RISK ACKNOWLEDGEMENT & HEALTH STATEMENT

- Exercise, weight/cardio/group training and the gym environment involve inherent risks including strains, sprains, falls, equipment injury, dizziness, fainting, dehydration, aggravation of existing conditions, serious injury, paralysis and death.
- Participation is voluntary and use of Dreamz services, premises, facilities and equipment is at the user's own risk. The user is responsible for correct use, suitable exercises and weights, warming up, stopping when needed and asking for help if unsure.
- The user confirms, to the best of their knowledge, that their health and physical condition allow safe use. A medical condition, injury, pregnancy, disability, symptom, medication issue or other safety concern requires appropriate medical advice before training and disclosure to staff only as necessary for immediate safety.
- Staff instructions, demonstrations, information and supervision are not medical advice, diagnosis or treatment. Stop and notify staff for pain, dizziness, shortness of breath, chest pain, unusual discomfort or an unsafe condition.

6. LIABILITY, RELEASE & MINORS

- To the maximum extent permitted by law, the user releases, indemnifies and holds harmless Dreamz Fitness, ABC Fitness & Health N.V., directors, management, staff, contractors, instructors, servants and agents from claims, actions, liabilities, losses, damages, costs and expenses arising from participation, gym use or misuse, breach of these terms or failure to follow instructions.
- No exclusion applies where law prohibits it, including intentional misconduct, gross negligence, reckless conduct or a mandatory legal duty that cannot be excluded. Non-waivable rights remain intact.
- For injury or property damage, the user will not bring a claim against Dreamz or ABC Fitness & Health N.V., except to the extent applicable law does not permit that waiver.
- For a member under 18, a parent or legal guardian must sign, authorizes participation and accepts financial responsibility for fees, damage and breaches.

7. SECURITY CAMERAS, CCTV & INCIDENT RECORDING

- Visible CCTV operates 24 hours per day, 7 days per week in and around entrances, reception, training and other safety/security-sensitive areas. No cameras are intended for toilets, bathrooms or changing areas.
- CCTV and incident recordings are used for safety, security, protection of persons/property, theft prevention, access control, incident handling, investigation, insurance, legal matters and rule enforcement. CCTV is never promotional content.
- Access is limited to authorized persons. Footage may be shared where reasonably necessary with police, emergency services, insurers, legal advisers or parties involved in an incident/legal process.
- Footage is retained no longer than necessary and in principle for up to 4 weeks, unless an incident, investigation, claim, legal obligation or safety/security reason requires longer handling.
- Dreamz may separately record incidents where reasonably necessary for safety, security, legal, insurance, damage, dispute or evidence purposes.

8. PRIVACY NOTICE

- Dreamz / ABC Fitness & Health N.V. processes personal, membership, payment, communication, emergency, security, incident, legal/insurance, rule-enforcement, signature and administration data for registration, access, service, evidence and legitimate business records.
- To recover from a tablet or browser interruption, an incomplete draft may be stored only on that tablet for up to 30 minutes after the last activity. It excludes signatures and the bank-account number and is cleared after server storage or when a new registration is started.
- Dreamz aims to process only necessary, relevant and non-excessive data, keep it secure and confidential, and retain it only as long as needed for administration, financial/legal obligations, disputes, claims, safety/security and legitimate records.
