MCB direct debit: from the 23rd (Bonaire time), the signup fee and current-month prorated charge are USD 0. The first full month normally joins the upcoming MCB batch around the 28th; if that batch has already closed, the full month remains due at the frontdesk.

CONTRACT TERMS & ACCEPTANCE

1. This membership has an initial minimum commitment period of 6 consecutive months. The discounted price is offered because the member commits to complete that entire period. Monthly payment is only a payment method and does not make the membership cancellable month-to-month.
 2. Payment is USD 420 upfront by cash/card or USD 70 monthly by MCB Bank Bonaire direct debit with an eligible current account and signed mandate. Before the 23rd, applicable signup and current-month prorated charges are due at the frontdesk. From the 23rd (Bonaire time), the signup fee and remaining-month charge are USD 0. Regular monthly collection is normally around the 28th. With a next-month start, the first full month remains payable at the frontdesk if it can no longer be included in the upcoming MCB batch.
 3. All months of the initial and every renewed commitment period remain due. Memberships and payments cannot be frozen, paused, transferred or refunded, except where a right cannot legally be excluded.
 4. Unless valid cancellation is completed on time, the membership automatically renews under the same conditions for a new minimum commitment period of the same 6-month duration. There is no limit to successive renewals. Every renewed period is binding and must be completed in full.
 5. Cancellation is only possible through the Dreamz Fitness member portal during the valid window. The window opens 30 calendar days before the end of the then-current period and remains open for 10 calendar days. A request outside that window does not end the current period and does not prevent the next automatic renewal. Cancellation is effective only after a successful confirmation or receipt.
 6. Cancellation is not processed while there are outstanding payments, arrears or another unpaid balance. Processing may occur once all outstanding amounts are fully paid, subject to applicable mandatory law.
 7. Temporary closure caused by government measures or other circumstances does not end the contract or monthly payment obligation. Official-holiday closures do not create a freeze or refund, including closures up to 7 consecutive days within 12 months, except where mandatory law requires otherwise.
 8. Except where mandatory law or a material failure by Dreamz requires otherwise, paid memberships, registration fees, add-ons, sessions and correctly supplied products are final and non-refundable from purchase, including same-day requests. Non-use, illness or injury, travel, relocation, schedule changes, dissatisfaction, change of mind or other personal circumstances create no refund, credit, pause or extension right.
 9. Direct debit cannot be cancelled before valid cancellation or completion of the then-current commitment period. The member agrees to receive membership and service information by email and/or WhatsApp and acknowledges that the signed contract copy is made available electronically.
 10. Bonaire/BES law applies. Nothing excludes intentional misconduct, gross negligence, reckless conduct or another mandatory legal duty that cannot be excluded.
